<p><b>24-02 Fair Housing Administration (ADM)</b>  Fair housing activities eliminating housing discrimination through the promotion of fair housing using education programs, monitoring, research and community involvement.  <b>Location: 1301 12<sup>th</sup> Street</b></p>	<p><b>\$ 30,000.00</b></p>
<p><b>24-03 Single Family Homeowner Rehabilitation (LMH)</b>  Rehabilitation loans to low- and moderate-income homeowners. Funding for lead-based paint remediation to assist low/moderate income homeowners as part of the City's rehabilitation program.  <b>Location: Citywide – Proposed Outcome: 10 Housing Units</b></p>	<p><b>\$465,511.00</b></p>
<p><b>24-04 Emergency Homeowner Roof Replacement (LMH)</b>  Owner occupied, low-moderate income homeowners that require emergency roof replacement in the City of Altoona. Assistance will be provided to homeowners at 0% interest, deferred loans to be forgiven at a rate of 25% a year over four years. The program is limited to roofs only.  <b>Location: Citywide – Proposed Outcome: 3 Housing Units</b></p>	<p><b>\$ 60,000.00</b></p>
<p><b>24-05 AHA Pleasant Village Roof Replacement (LMH)</b>  Removal and replacement of all roofs on seventeen (17) buildings (126-units) at the Altoona Housing Authority's Pleasant Village Apartments.  <b>Location: 2700 Pleasant Valley Boulevard – Proposed Outcome: 126 units</b></p>	<p><b>\$225,000.00</b></p>
<p><b>24-06 Altoona Fire Department – Hurst Rescue Tools (Jaws of Life) (LMA)</b>  This equipment will be placed at Fire District 330 serving primarily low/moderate income. This Fire Station serves Census Tracts 1015 BG 1,2,3; C.T.1016 BG 1,2,3; 1017 BG 1,2,3,4; C.T. 1018 BG 1,2,3. L/M Universe 12,300 persons with 6,895 being L/M or 56.06%.</p>	<p><b>\$ 35,983.20</b></p>
<p><b>24-07 Altoona Fire Department – SuperVac Pressure Ventilations Fans (LMA)</b>  Purchase of three sixteen-inch and one eighteen-inch Super Vac battery-powered positive pressure ventilation fans (PPV) used at fire scenes to remove smoke, heat, and combustion products by using a positive airflow.  <b>Location: 1319 Washington Avenue (310) serving Census Tracts 1003 BG 1,2,3,</b></p>	<p><b>\$ 20,230.00</b></p>

**24-10 Overflow Church Meal Preparation (LMA)(PS) \$25,000.00**  
Providing free meals to anyone in need in the East End area of the City of Altoona.  
**Location: C.T. 1017 BG2, BG3, BG4; Proposed Outcome: 3,120 People**

**24-11 Emergency Housing Assistance – (LMC)(PS) \$25,000.00**  
Rent/Utility Payments (not to exceed 3 months) to households experiencing Homelessness or at risk of homelessness.  
**Proposed Outcome: 54 persons**
