The meeting was televised live on cable Public Access Channel 14 and rebroadcast March 14, 2023.

CALL TO ORDER – by Mayor Pacifico at 6:15 PM in Council Chambers, following an executive session SILENT MEDITATION PLEDGE OF ALLEGIANCE

ALL PUBLIC COMMENT - Devin Saylor of 424 Crawford Avenue provided Council with a community clean-up project that he plans to hold in May stating he registered his event with Keep PA Beautiful

Don Bowers of Lloyd Street stated he has worked for the Altoona Parking Authority for 17 years and that there is a terrible homeless situation in the City of Altoona; Mr. Bowers asked Council to provide pandemic money for shelters
