City of Altoona Ordinance #5345 provides for the parking/placement of all waste dumpsters and waste containers upon the streets and sidewalks of Altoona.

**REQUIREMENTS**

1. The dumpster/container must be illuminated with a warning light, light reflector or a reflectorized material visible to oncoming vehicles for a distance of not less than three hundred (300') feet between the hours of sunset and sunrise.
2. The dumpster/container must be equipped with a cover so that when not in use, the container will not accumulate significant amounts of water so as to cause leakage.
3. Liquid leachate may not leak from the container onto any street, sidewalk or public right-of-way.
4. Only permitted, non-recyclable waste may be placed in such containers in compliance with City Ordinances #5158 and #5183 or their guidelines.
5. The name of the company responsible for the placement and removal of the waste dumpster must be displayed on same as well as the dumpster tag.
6. At no time will a dumpster/container be placed onto any running lane of the roadway restricting the flow of traffic.

It is the duty of the Altoona Police Department or any officer of the Department of Codes & Inspections to enforce the provisions of Ordinance #5345. Whosoever violates any of the provisions of this Ordinance shall, upon conviction thereof, be sentenced to pay a fine of not less than one hundred (\$100) dollars nor more than one thousand (\$1,000) dollars and/or to be imprisoned for a period not to exceed ninety (90) days.
