AN ORDINANCE OF THE CITY OF ALTOONA AMENDING AND RESTATING CHAPTER 105 OF THE CODE OF THE CITY OF ALTOONA ENTITLED "POLICE CIVIL SERVICE COMMISSION" TO COMPLY WITH APPLICABLE LAW BY AMENDING AND REPLACING THE CITY OF ALTOONA POLICE CIVIL SERVICE RULES AND REGULATIONS; REPEAL OF ALL OTHER ORDINANCES OR PARTS OF LAWS IN CONFLICT THEREWITH; PROVIDE A SEVERABILITY OF PROVISIONS; PROVIDE AN OBJECTIVE FOR THE ORDINANCE; AND ESTABLISH AN EFFECTIVE DATE.

Be it ordained by the Council of the City of Altoona as follows:

SECTION 1. AMENDMENT TO CHAPTER 105. Chapter 105 of the Code of the City of

Altoona entitled "Police Civil Service Commission" is hereby amended and restated in its entirety by replacing Article I entitled "Rules and Regulations" with the attached Exhibit "A" entitled "Police Civil Service Rules and Regulations".

SECTION 2. OBJECTIVE/AMENDMENT/SEVERABILITY AND RESTATEMENT/REPEAL.

The primary objective of this Ordinance is to comply with applicable law. Any prior enactment imposing such rules and regulations is amended and restated in its entirety to read as stated in this Ordinance. Any other prior enactment or part of any prior enactment conflicting with the provisions of this Ordinance is rescinded insofar as the conflict exists. To the extent the same as any enactment in force immediately prior to adoption of this Ordinance, the provisions of this Ordinance are intended as a continuation of such prior enactment and not as a new enactment. If this Ordinance is declared invalid, any prior enactment for police civil service rules and regulations shall remain in full force and effect and shall not be affected by adoption of this Ordinance, and/or this Ordinance shall be considered to have been enacted under authority of any other law permitting this Ordinance to be valid. If any part of this Ordinance is declared invalid, the similar part of any prior enactment providing for zoning regulations shall remain in effect and shall not be affected by adoption of this Ordinance, and/or such part or parts of this Ordinance shall be considered to have been enacted under authority of any other law permitting any such part of this Ordinance to be valid. The provisions of this Ordinance shall not affect any act done or liability incurred, nor shall such provisions affect any suit or prosecution pending or to be initiated to enforce any right or penalty or to punish offense under the authority of any

enactment in force prior to adoption of this Ordinance. Subject to the foregoing provisions of this Section, this Ordinance shall amend and restate on the Effective Date any enactment for police civil service rules and regulations in force immediately prior to the Effective Date.

SECTION 4. EFFECTIVE DATE.

This Ordinance shall become effective at the earliest possible date provided by law.
