LERTA BOUNDARY

ALL THAT CERTAIN real property situated in the City of Altoona, County of Blair, and Commonwealth of Pennsylvania and being more particular described as follows:

BEGININNING; at a point of intersection of the Southwesterly right-of-way line of 4th Street and the Southeasterly right-of-way of Willow Avenue, said point being the TRUE POINT OF BEGINNING; thence leaving said True Point of Beginning and along the Southwesterly right-ofway line of 4th Street, in a Southeasterly direction, an approximate distance of four hundred forty, more or less (440.0'+/-) feet to a point and intersection of the Southeasterly right-of way line of Howard Avenue Alley; thence leaving said point and along the Southeasterly right-of-way line of Howard Avenue Alley in a Northeasterly direction, an approximate distance of one thousand four hundred, more or less (1,400.0'+/-) feet to a point of transition from Howard Avenue Alley to the Southeasterly right-of-way line of Pennway Avenue; thence leaving said point and along the Southeasterly right-of-way line of Pennway Avenue in a Northeasterly direction, an approximate distance of eight hundred forty-two, more or less (842.0'+/-) feet to a point and intersection of the Northeasterly division line of lands now or formerly of Chestnut Avenue LP; thence leaving said point and along the Northeasterly division line of lands now or formerly of Chestnut Avenue LP in a Southeasterly direction, an approximate distance of two hundred, more or less (200.0'+/-) feet to a point and intersection of the Northwesterly division line of lands now or formerly of the City of Altoona, also being the Southeasterly right-of-way line of 5th Avenue (proposed), never dedicated nor opened; thence leaving said point and along the Southeasterly right-of-way line of 5th Avenue (proposed), never dedicated nor opened and crossing Juniata Gap Road in a Northeasterly direction, an approximate distance of two thousand one hundred ten, more or less (2,110.0'+/-) feet to a point and intersection of the Southwesterly right-of-way line of Broadway produced; thence leaving said point and along the Southwesterly right-of-way line of Broadway produced in a Southeasterly direction, an approximate distance of three hundred fifty, more or less (350.0'+/-) feet to a point of transition from the Southeasterly right-of-way line of North 4th Avenue to East Chestnut Avenue; thence leaving said point and along the Southeasterly right-of-way line of East Chestnut Avenue in a Southwesterly direction, an approximated distance of four thousand three hundred forty-five, more or less (4,345.0'+/-) feet to a point and intersection of the Southwesterly right-of-way line of 4th Street; thence leaving said point and along the Southwesterly right-of-way line of 4th Street in a Southeasterly direction, an approximate distance of two thousand one hundred sixty-seven, more or less (2,167.0'+/-) feet to a point and intersection of the Northwesterly right-of-way line of 6th Avenue; thence leaving said point and along the Northwesterly right-of-way line of 6th Avenue in a Southwesterly direction, an approximate distance of five thousand one hundred eight-one, more or less (5,181.0'+/-) feet to

a point and intersection of the Southwesterly right-of-way line of 17th Street; thence leaving said point and along the Southwesterly right-of-way line of 17th Street in a Northwesterly direction, an approximate distance of six hundred nine, more or less (609.0'+/-) feet to appoint and intersection of the Northwesterly right-of-way line of 8th Avenue; thence leaving said point and along the Northwesterly right-of-way line of 8th Avenue in a Southwesterly direction, an approximate distance of two thousand five hundred one, more or less (2,501.0'+/-) feet to a point and intersection of the Southeasterly right-of-way line of Union Avenue with the Northeasterly right-of-way line of 24th Street; thence leaving said point and along the Northeasterly right-of-way line of 24th Street in a Northwesterly direction, an approximate distance of one thousand one hundred sixty-seven, more or less (1,167.0'+/-) feet to a point and intersection of the Southeasterly right-of-way line of Broad Avenue Alley; thence leaving said point and along the Southeasterly right-of-way line of Broad Avenue Alley in a Northeasterly direction, an approximate distance of three hundred, more or less (300.0'+/-) feet to appoint and intersection of the Southwesterly right-of-way line of 23rd Street; thence leaving said point and along the Southwesterly right-of-way line of 23rd Street in a Southeasterly direction, an approximate distance of two hundred fifty, more or less (250.0'+/-) feet to a point and intersection of the Northwesterly right-o-way line of Broad Avenue; thence leaving said point and along the Northwesterly right-of-way line of Broad Avenue in a Northeasterly direction, an approximate distance of six hundred, more or less (600.0'+/-) feet to a point and intersection of the Northeasterly right-of-way line of 22nd Street; thence leaving said point and along the Northeasterly right-of-way line of 22nd Street in a Northwesterly direction, an approximate distance of one hundred thirty-six, more or less (136.0'+/-) feet to a point and intersection of the Southwesterly right-of-way line of Broad Avenue Alley; thence leaving said point and along the Southwesterly right-of-way line of Broad Avenue Alley in a Northeasterly direction, an approximate distance of four hundred ninety-three, more or less (493.0'+/-) feet to a point and intersection of the Southwesterly right-of-wqay line of Union Avenue Alley; thence leaving said point and along the Southwesterly right-of-way line of Union Avenue Alley in a Northeasterly direction, an approximate distance of seven hundred twenty, more or less (720.0'+/-) feet to a point and intersection of the Northwesterly right-of-way line of 19th Street; thence leaving said point and along the Northwesterly right-of-way line of 19th Street in a Southwesterly direction, an approximate distance of sixty-four, more or less (64.0'+/-) feet to a point and intersection of the Northwesterly right-of-way line of Pine Avenue; thence leaving said point and along the Northwesterly right-of-way line of Pine Avenue in a Southwesterly direction, an approximate distance of ninety-six, more or less (96.0'+/-) feet to a point and intersection of the Northeasterly right-of-way line of an Un-named Alley; thence leaving said point and along the Northeasterly right-of-way line of Un-named Alley in a Northwesterly direction, an approximate distance of ninety-nine, more or Less (99.0'+/-) feet to a point and intersection of the Southeasterly right-of-way line of Pa Lines, LLC a/k/a Norfolk Southern Main Line; thence leaving said point and along the Southeasterly right-of-way of Pa Lines, LLC a/k/a Norfolk Southern Main Line in a northeasterly direction, an approximate distance of four hundred twenty-four, more or less (424.0'+/-) feet to a point and intersection of the Southwesterly right-of-way line of 18th Street SR 0036; thence leaving said point and along/through/under the Norfolk Southern Main Line right-of-way and along the Southwesterly right-of-way line of 18th Street in a Northwesterly direction, an approximate distance of one

thousand forty, more or less (1,040.0'+/-) feet to a point and intersection of the Southeasterly right-of-way line of 13th Avenue; thence leaving said point and along the Southeasterly right-ofway line of 13th Avenue in a Northeasterly direction, an approximate distance of six hundred ninety-five, more or less (695.0'+/-) feet to a point and intersection of the Northeasterly rightof-way line of 16th Street; thence leaving said point and along the Northeasterly right-of-way line of 16th Street in a Northwesterly direction, an approximate distance of one hundred seventy-one, more or less (171.0'+/-) feet to a point and intersection of the Southeasterly rightof-way line of 13th Avenue Alley; thence leaving said point and along the Southeasterly right-ofway line of 13th Avenue Alley in a Northeasterly direction, an approximate distance of eight hundred twenty-five, more or less (825.0'+/-) feet to a point and intersection of the Northeasterly right-of-way line of 14th Street; thence leaving said point and along the Northeasterly right-of-way line of 14th Street in a Northwesterly direction, an approximate distance of one hundred thirty-five, more or less (135.0'+/-) feet to a point and intersection of the Southeasterly right-of-way line of 14th Avenue; thence leaving said point and along the Southeasterly right-of-way line of 14th Avenue in a Northeasterly direction, an approximate distance of four hundred, more or less (400.0'+/-) feet to a point and intersection of the Southwesterly right-of-way line of 13th Street; thence leaving said point and along the Southwesterly right-of-way line of 13th Street in a Southeasterly direction, an approximate distance of one hundred twenty, more or less (120.0'+/-) feet to a point and intersection of the Northwesterly right-of-way line of 13th Avenue Alley; thence leaving said point and along the Northwesterly right-of-way line of 13th Avenue Alley in a Northeasterly direction, an approximate distance of nine hundred five, more or less (905.0'+/-) feet to a point and intersection of the Southwesterly right-of-way line of 11th Street; thence leaving said point and along the Southwesterly right-of-way line of 11th Street in a Northwesterly direction, an approximate distance of fifty-five, more or less (55.0'+/-) feet to a point and intersection of the Northwesterly right-of-way line of Lexington Avenue; thence leaving said point and along the Northwesterly right-of-way line of Lexington Avenue in a Northeasterly direction, an approximate distance of twenty, more or less (20.0'+/-) feet to a point and intersection of the Southwesterly right-of-way line of 11th Street; thence leaving said point and along the Southwesterly right-of-way line of 11th Street in a Northwesterly direction, an approximate distance of one thousand seven hundred ninety-five, more or less (1,795.0'+/-) feet to a point and intersection of the Southeasterly right-of-way line of 19th Avenue; thence leaving said point and along the Southeasterly right-of way line of 19th Avenue in a Southwesterly direction, an approximate distance of three hundred seventy-one, more or less (371.0'+/-) feet to a point and intersection of the Northeasterly right-of-way line of 12th Street; thence leaving said point and along the Northeasterly right-of-way line of 12th Street in a Northwesterly direction, an approximate distance of three hundred eleven, more or less (311.0'+/-) feet to a point and intersection of the Southeasterly right-of-way line of 20th Avenue; thence leaving said point and along the Southeasterly right-of-way line of 20th Avenue in a Northeasterly direction, an approximate distance of five hundred twenty-eight, more or less (528.0'+/-) feet to a point and intersection of the Southwesterly right-of-way line of 10th Street; thence leaving said point and along the Southwesterly right-of-way line of 10th Street in a Southeasterly direction, an approximate distance of seven hundred seven, more or less (707.0'+/-) feet to a point and intersection where 10th Street merges with 9th Street; thence leaving said point of merger with

9th Street continuing along the Southwesterly right-of-way line of now 9th Street in a Southeasterly direction, an approximate distance of seven hundred thirty, more or less (730.0'+/-) feet to a point and intersection of the Northwesterly right-of-way line of Willow Avenue produced; thence leaving said point continuing across 9th Street and along the Northwesterly right-of-way line of Willow Avenue in a Northeasterly direction, an approximate distance of one thousand thirty, more or less (1,030.0'+/-) feet to a point and intersection of the Southwesterly right-of-way line of 5th Street; thence leaving said point and along the Southwesterly right-of-way line of 5th Street in a Northwesterly direction, an approximate distance of twenty, more or less (20.0'+/-) feet to a point and intersection of the Southeasterly right-of-way line of Willow Avenue in a Northeasterly direction, an approximate distance of four hundred fifty, more or less (450.0'+/-) feet to the True Point of Beginning.
