THE FUEL TYPE OF EACH TANK SHALL ALSO BE INCLUDED. A FEE OF \$100.00 PER TANK MUST BE PAID IN ADVANCE OF THE PROJECT DESCRIBED. A PERMIT WILL BE ISSUED UPON RECEIPT OF PAYMENT
