# ALTOONA CITY COUNCIL MEETING MINUTES MONDAY – JUNE 12, 2023 - 6:00 P.M. CITY OF ALTOONA TRAINING FACILITY & COUNCIL CHAMBERS 1320 WASHINGTON AVENUE, ALTOONA, PA

The meeting was televised live on cable Public Access Channel 14 and re-broadcast June 13, 2023.

CALL TO ORDER – by Mayor Pacifico at 6:15 PM in Council Chambers following a public hearing

Mayor Pacifico read a statement regarding rental license revocation and Operation Safe Space as follows:

In January City Council passed legislation giving the Codes Department authorization to issue a five-year rental license revocation for owners of rental property who are grossly negligent and habitually non-compliant with the City's residential rental unit registration program. This decision was the result of extensive research and study conducted by the Codes Department into rental programs in other cities and municipalities throughout the Commonwealth of Pennsylvania, with many of them having successful rental revocation policies. Based on the findings, it was determined that additional tools were necessary here in Altoona to ensure landlords maintain their rental properties in a decent, safe and sanitary condition - that meet minimum standards of habitability. It is important to note, and I want to emphasize, that the license revocation process that has been put into place is based on very specific criteria, which is outlined in the ordinance, and is reserved only for landlords with repeated and consistent non-compliance of derelict properties. It is not meant for the many responsible landlords who provide safe, clean and quality housing for their tenants, here in the City. Since the adoption of this policy, three landlords operating in the City of Altoona have been issued five-year rental license revocations for all of their rental properties. Operation Safe Space, a program developed to assist tenants with relocation from properties under license revocation, has been used to help the tenants in these three cases with positive results. The City remains committed to prioritizing the utmost safety and well-being of all residents in our community, and preventing rental properties from becoming an influence that fosters blight and deterioration in our City. We encourage and look forward to working with responsible investors and landlords who are interested in providing clean and safe housing for their tenants.

### CITY MANAGER UPDATES

City Manager Omar Strohm provided the following:

- -staff is looking at a new intermunicipal stormwater agreement and the member municipalities are looking at a two-year agreement; the City is the largest participant and the City participates with the largest percentage of the total which is based on 30% population, 20% stream length within the municipality and 50% impervious surfaces; the City's portion amounts to \$283,000 over the next two years; this will be coming before Council in the near future for a vote;
- -czb meetings are continuing with staff
- -the financial audit is almost complete; it will be distributed to Council and then presented at the August meeting
- -City Hall is closed Wednesday, June 14<sup>th</sup> for Flag Day

#### MAYOR & COUNCIL DISCUSSION ITEMS AND ANNOUNCEMENTS

Mayor and Council thanked everyone for their continued help with Prospect Pool and all that played a heavy part in getting the pool opened

Councilman Ellis thanked Omar and Nate for leading Prospect Pool and Councilman Beatty for making it all come together; it's been a great thing for the community and a lot of people reached out with appreciation; thanks to Overflow Church, Pastor Cox and the volunteers for their four clean-ups/fix-ups that they held in May; they filled numerous roll offs provided by Burgmeier's and they also replaced porch railings and replaced a garage roof, shed roof and porch roof that had received code violations

Councilman Beatty thanked the citizens that showed up for the opening day at the pool as there was a record crowd of nearly 700 people in attendance; Councilman Beatty stated the opening went smoothly and thanked the following: employees and the YMCA lifeguards, CBRC for balancing the water, Nate Kissell and DPW for cutting grass and for the railing on the sundeck and for making it safe, and for all of the work that they did and Omar Strohm; the concession stand is stocked with good food and the sundeck is now open to use; Councilman Beatty stated Prospect Pool is safe and clean now and that is how the City intends to keep it

Mayor Pacifico stated the Comprehensive Plan open houses will be held July  $10^{th}$  at 3 pm at Juniata Civics, July  $11^{th}$  at Altoona Area High School at 12 noon and July  $11^{th}$  at the Trolleyworks at 5:30 pm; all are welcome to attend and to participate and the information is on the City's website at www.altoonapa.gov
