Pam Mitchell of 307 Cherry Avenue spoke about the Gable's Building and her dissatisfaction with her interaction with the City

Amy Koegler of 417 Grant Avenue stated she received a tour of a home by Councilman Beatty that was her home growing up and was able to see what he is trying to do to get homes rehabbed in the City rather than tearing them down. Ms. Koegler states she thinks it is a great idea and the homes should be rehabbed rather than demolished and lose taxes on them.

MAYOR & COUNCIL DISCUSSION ITEMS AND ANNOUNCEMENTS

Councilman Ellis read the following statement into the record:

"I thank the responsible property owners and landlords who have invested in the City for the right reasons and for following the rules. We encourage responsible investors to make Altoona part of their plans. Over the past year our community has made significant progress impacting and protecting our citizens from unscrupulous landlords and delinquent property owners. The success of the past year is a tribute to the work of our staff and their partnership with the great work of several social service agencies. Moving into 2024, we as a Council need to insure our employees have the necessary tools and support to continue with rental inspections license suspensions of delinquent, non-compliant landlords. necessary, to require property owners to be more accountable. To many, property owners in our City insulate themselves by using surrogates, managers, agents and others, resulting in City staff spending unnecessary time attempting to resolve issues. I do not work at City Hall every day, all day, but I am sick and tired of the absent, money hungry, property owners doing business here with no exposure to, or accepting responsibility for the conditions of their properties or the behavior of their surrogates, managers, and agents. I thank the responsible property owners and landlords who have invested in our City for the right reasons and who follow the rules. We encourage responsible investors to make Altoona part of their plans."

Councilman Beatty thanked the City for their response to the Gable's Building and for doing their job and commended staff for all that they did

Councilwoman Clinich thanked City staff for her orientation to the City and for the different departments who took the time to show her around and to make her feel very welcome. In doing the orientation, it was clear in each department, how much they care for the City. Councilwoman Clinich stated she appreciates everyone involved and wanted to say thank you.
