

Fire Prevention Week



Fire Prevention Week is October 5th – 11th, 2025. This year's theme is "Charge into Fire Safety – Lithium Batteries in Your Home". The campaign aims to educate the public on the safe purchase, use, charging and recycling of lithium-ion batteries to prevent fires.

Lithium—ion batteries power many household devices today, including smartphones, laptops, headphones and even toys. Incorrectly handled or damaged batteries can overheat and cause serious fires or explosions. The three key messages of this campaign are:

Buy only tested products – look for a nationally recognized testing lab on the packaging to ensure it meets established safety standards.

Charge devices safely – use the cables that come with the product and charge it on a hard surface, not under a pillow or on a bed or couch, where it could start a fire. And don't overcharge your device. Unplug it when it's fully charged to avoid overheating.

Dispose of / recycle batteries properly – do not throw them in regular recycling bins or in the trash; recycle your device or battery at a safe battery recycling location.

Halloween Safety 2025

TRICK OR TREAT IN ALTOONA WILL BE THURSDAY, OCTOBER 30th FROM 6 PM - 8 PM

FOR KIDS:

- 1. Choose face paint and makeup whenever possible instead of masks, which can obstruct a child's vision.
- 2. Have kids carry glow sticks or flashlights to help them see and be seen by drivers.
- 3. Decorate costumes / bags with reflective tape or stickers and, if possible, choose light colors.
- Cross the street at corners, using traffic signals and crosswalks. Look both ways when crossing and keep looking as you cross.
- 5. Put electronic devices down, keep heads up and walk, don't run, across the street.

FOR DRIVERS:

- 1. Slow down and be especially alert in residential neighborhoods. Children are excited on Halloween and may move in unpredictable ways.
- 2. Take extra time to look for kids at intersections, on medians and on curbs.
- 3. Enter and exit driveways and alleys slowly and carefully.
- 4. Turn headlights on earlier to spot children at greater distances.

Learn About Your City

Whether you are new to the City of Altoona, or have been a resident all your life, there is a lot to know about the many departments and boards that help the City to operate and thrive every day. For the next several months, we will focus on one department each month, so you can learn a little about them and what they do. We hope this will help our citizens better understand and appreciate how the departments work together for the betterment of all of us. You may also be surprised at the many things each department is responsible for!

This month, we will start with:

The Office of the City Manager

Since 2015, the City of Altoona has operated under the Council-Manager government system, as defined by a Home Rule Charter and Optional Plans Law, which distinguishes the roles and responsibilities of the Mayor and the City Manager. Many citizens are often unclear about the differences between these positions.

The Mayor is an elected official who handles constituent issues and represents the City's interests in the community, at conferences and in dealings with state and federal governments. As the public face of the City, the Mayor plays a key role in shaping policy alongside City Council and actively promotes the City's economic development, employment, revitalization, and housing improvement. However, the Mayor does not oversee the daily operations of City Departments or staff.

Conversely, the City Manager is an appointed position that reports directly to the City Council. The City Manager provides professional leadership and management, supervising all City departments and staff to ensure efficient municipal operations within our City. The City Manager is also responsible for appointing department heads, managing budgets, implementing policies and programs and coordinates City events and public functions.
