## 2. Approval of the Minutes

The Minutes of the Friday, September 20, 2019 meeting were reviewed. A motion was made to approve the minutes as read by Ron Beatty and seconded by Matt Pacifico, which passed unanimously.

AMTRAK has always paid for this service. Since, it has been determined that the City of Altoona owns the elevators, therefore the Redevelopment Authority will taking over this contract. Attorney Benjamin would like to have some time to go over the contract, so her suggestion was to approve the contract contingent on her findings. A motion was made by Ron Beatty and seconded by Matt Pacifico. Motion passed unanimously.
- c. Release of Restrictions on Deed 1213 4<sup>th</sup> Avenue, Juniata Attorney Benjamin presented a letter from Attorney Rosensteel requesting the Release of Restrictions on a Deed identified as the North Easterly 1/2 portion of the woods at 1213 4<sup>th</sup> Avenue, Juniata. A brief discussion ensued, Matt Pacifico made a motion that the Redevelopment Authority Release the Reverter Rights on this deed. Ron Beatty seconded the motion. Motion passed unanimously.
