Assistance may include preparing a project request and completing the application form or any such assistance necessary to aid in understanding and participation. Citizens who wish to review information obtained by the City for the development of the 5-Year HUD Consolidated Plan or Annual Plan may do so by contacting the City. Meetings were previously held to develop the documents and were open to the public pursuant to the Pennsylvania Sunshine Act. Citizens may request a copy of the summary of the meetings. If you are unable to attend the community public hearings and wish to comment, or if you wish to obtain a project application form, please contact the City, at the address or phone numbers shown below, for assistance. Comments can be made at any time, in person, by phone, FAX, mail or email. Project requests must be submitted in writing using the City's application form which can be obtained on the City's Website at "https://www.altoonapa.gov" listed under Community Development and must be submitted by Friday, March 24, 2023.

All meetings are held in locations that are accessible to persons with disabilities. Upon request, the City of Altoona will accommodate the needs of participants with hearing or visual impairments and non-English speaking participants who identify those needs in advance. Information will be made available upon request in large print, on audio tape or in Braille. Please contact the City at the address or phone numbers shown below. A Consolidated Annual Performance and Evaluation Report (CAPER) is prepared by the City after the close of each program year. The 2022 CAPER will be available for review no later than August 25, 2023, for a 15-day

comment period and a public hearing before filing with HUD. The CAPERs are available for review upon request. The City will respond to all written complaints within 15 days, when practicable.
