- IN ADDITION TO THIS FORM, PLEASE ATTACH A NARRATIVE THAT EXPLAINS THIS REQUEST. THE NARRATIVE SHOULD EXPLAIN POINTS UPON WHICH THE APPEAL IS BASED.
- ALSO REQUIRED ARE ANY DRAWINGS, PHOTOGRAPHS, AND SUPPORTING MATERIALS.
- FOR SPECIAL EXCEPTION APPLICATIONS, THE NARRATIVE MUST EXPLAIN HOW THE PROJECT MEETS EACH CONDITION
  FOR THE SPECIAL EXCEPTIONS LISTED IN THE INVOLVED ZONING DISTRICT'S REGULATIONS.
- FOR VARIANCE APPLICATIONS, THIS NARRATIVE MUST EXPLAIN HOW THE PROJECT MEETS THE REQUIREMENTS OF SECTION 910.2 OF THE PENNSYLVANIA MUNICIPALITIES PLANNING CODE.
- THE APPLICANT SHOULD WORK WITH THE CITY TO DEVELOP A COMPLETE SUBMISSION, AS INCOMPLETE SUBMISSIONS WILL NOT BE PLACED ON THE AGENDA.
