ROLL CALL – taken by City Clerk Linda Rickens Schellhammer Present: Council members Beatty, Butterbaugh, Clinich, Ellis, Ickes, Kelley (via phone) and Mayor Pacifico

City Manager Chris McGuire reviewed the park vacation for Fairview Park and the lot lines map prior to the meeting, stating, the City is not taking the park away. The City is merging the lots in order to streamline the grant process for future funding for the park.

ALL PUBLIC COMMENT

Bonita Shreve of 1413 Ivyside Drive stated she is against the expenditure of taxpayer money on the Pride Parade that is scheduled in downtown Altoona in October and that she is against police presence and the parade should move back to Penn State Altoona.

Tom Meyers of 1115 27th Avenue stated the gas company made street cuts that are not done properly in his neighborhood and asked why they are breaking OSHA rules; Mr. Meyers also stated there was no shoring; the hole was 3 feet deep; Council stated they will ask staff to look into his concerns
