ALL PUBLIC COMMENT – Katie Buchanan, no address given, Altoona, PA stated there are many rumors regarding Keith Athletic Field and understands that it is owned by the Altoona Area School District and asked for Council to be transparent and to treat it like they treated Prospect Pool; development would affect safety in the neighborhood and stormwater would affect those downhill; asked Council to leave it as greenspace

Jordan Wild of Ecological Landscapes, no address given, stated he is working with DCNR and asked Council to keep him in mind when considering solutions for replacing stormwater run off and for grass spaces as he can enhance the areas with raingardens and wildflower meadows; stated he assisted with moving a tree recently that was a hazard near St. Therese and planted bushes and trees with Holy Trinity students

Devin Saylor of 424 Crawford Ave, Altoona stated the Altoona Housing Authority needs a bigger meeting space and more transparency with agendas, etc.; Councilman Cooper stated he serves as Chairman of the Altoona Housing Aughority and he is happy to discuss suggestions and concerns

2) AN ORDINANCE OF THE CITY OF ALTOONA, COUNTY OF BLAIR, COMMONWEALTH OF PENNSYLVANIA AMENDING CHAPTER 646 ENTITLED "TAXATION" AND IN PARTICULAR §646-96 "MILLAGE ESTABLISHED: ONGOING TAX" ESTABLISHING THE TAX RATE FOR ALL REAL ESTATE SUBJECT TO TAXATION LOCATED IN THE CITY OF ALTOONA, PENNSYLVANIA, AT A RATE OF <u>5.629</u> MILLS FOR THE YEAR
